PROJECT SCOPE AND LOCATION:

This subaward is funded through the Federal Highway Administration (hereinafter FHWA), Grant RT15012 to the Jim Wells County (hereinafter Sponsor) for the construction and renovation of 0.33 miles +/- recreational trail, signage, playground equipment, fencing, restrooms, exercise stations, resource surveys and engineeringat Tecolote Trails under the authority of the Recreational Trails Grant Program, (CFDA# 20.219) issued to Texas Parks and Wildlife Department, Recreational Trails Program (hereinafter TPWD) on date of award March 12, 2018. All publications arising from this project shall acknowledge TPWD, as well as FHWA, as funding sources.

Sponsor is authorized to construct 0.33 miles */- recreational trail, signage, playground equipment, fencing, restrooms, exercise stations, resource surveys and engineering at Tecolote Trails in Jim Wells County, Texas.

TPWD and Sponsor agree that the total cost of the Project is Sixty-Five Thousand Six Hundred Eighty Dollars (\$65,680.00) and that reimbursement to Sponsor for work performed under this agreement will not exceed Eighty Percent (80%) of the project cost up to the grant funds approved, Fifty-Two Thousand Five Hundred Forty-Four Dollars (\$52,544.00).
