Approximate Quantity 55,000 sq. yds. - Ac-10 .28 gal/sy - GR-4 1cy/100sy

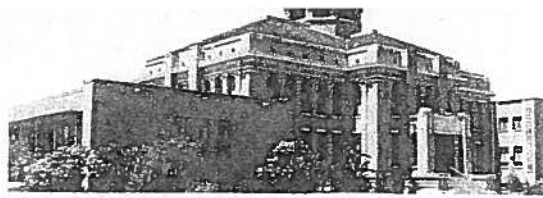
Double Course:

Ac-15P .28 gal/sy - GR-4 1cy/100sy (2<sup>nd</sup> course)

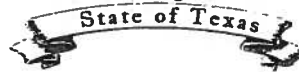
