- 1. Bid Forms: Bids shall be submitted only on the bid forms provided by the County. All pages included in this Invitation to Bid that are marked Bid Forms must be completed and returned as part of the bid document.  - 2) For claims against Jim Wells Connty by third parties in the amount of \$100,000 for damage to or destruction of property arising out of each occurrence, the amount of \$300,00 to any person for any number of claims arising out of each

 - 3) Liability insurance of not less than \$500,000 for each occurrence with an aggregate of \$1,000,000 for the term of the policy with respect to property damage.

The vendor will be required to furnish evidence that the drivers, employed by the vendor to operate equipment included in the contract, will be covered by insurance, as required in the Texas Workers' Compensation Act.
